**ORDER ON RECEIVER’S MOTION TO PROHIBIT DISTRIBUTIONS

IT IS THEREFORE ORDERED, ADJUDGED AND DECREED that no distributions from the Receivership Estate shall be made under the Approved Alternative Alanar Receivership Plan based on accounts held by Defendants, Vaughn A. Reeves, Sr., Vaughn A. Reeves, Jr., Jonathan Christopher Reeves and Joshua Craig Reeves, including any jointly held accounts and non-qualified retirement accounts, with the amounts of any prohibited distributions to be retained

by the Receivership Estate and credited against the May 19, 2008 Final Judgments entered by this Court against the respective Reeves Defendants.
